

COVID-19 PERIODIC UPDATE

JULY 6, 2020

Greetings from the offices of the Bee County Judge and the Mayor of the City of Beeville. In an effort to reduce the length of this update, we have removed information on previous daily updates. Please know that you can access the full text of all prior daily updates on our Bee OEM Facebook page.

The numbers below speak for themselves. On Friday evening we received notice of 4 new cases, on Saturday 10 more came through, and last night it was 16. Please follow the mask order; social distance; wash your hands; and stay safe.

As of 6:30 this morning, July 6, 2020, according to the Texas Department of State Health Services (“DSHS”) Dashboard,¹ Bee County currently has

23 active cases;
36 recovered cases; and
69 total cases (non-prisoner and prisoner) since tracking began.

These numbers from DSHS are not accurate – our total case count is higher which means our recovered case count should be higher. And, our active case count could be higher as well. If there are 19 total inmate cases (see 2 paragraphs below), and 66 community cases, then the Bee County confirmed total is: **85 total cases since tracking began.**

Bee County is situated in DSHS Region 11. Region 11 tracks non-inmate COVID-19 cases in Bee County, including contact tracing and quarantine management. The DSHS Dashboard, on the other hand, is maintained by DSHS in Austin, and in Austin, DSHS counts both non-inmate and inmate cases together.²

The Texas Department of Criminal Justice (“TDCJ”) Dashboard,³ reflects only 1 active inmate case, within the McConnell Unit. The TDCJ Dashboard reflects 18 “recovered” inmate cases.

Assuming the DSHS “active” case number is accurate (which we know it is not), and 1 of the “active” cases is an inmate, then Bee County (non-inmate) has 22 “active” cases.
