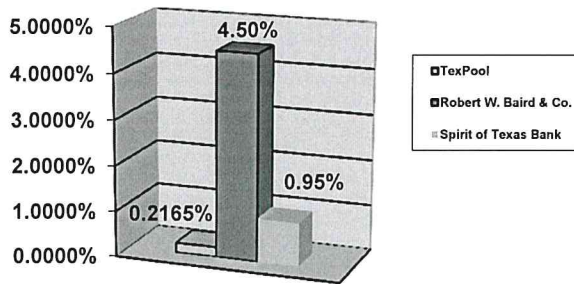

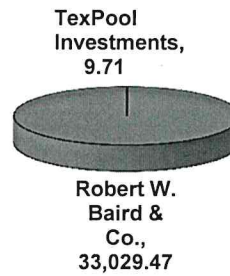

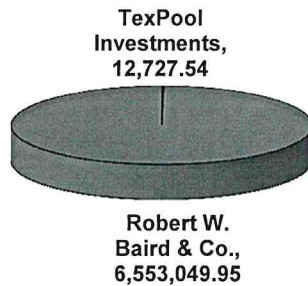
**Interest Rates For the Quarter Ended
