

COVID-19 PERIODIC UPDATE

JULY 2, 2020

Greetings from the offices of the Bee County Judge and the Mayor of the City of Beeville. In an effort to reduce the length of this update, we have removed information on previous daily updates. Please know that you can access the full text of all prior daily updates on our Bee OEM Facebook page.

CASE UPDATE

Since the last Covid-19 Periodic Update, dated July 1, 2020, DSHS has notified Bee County of the following additional community cases (which simply means – “non-TDCJ inmate”):

Case No. 28 – Female in her teens (confirmed 7.1.20);

Case No. 29 – Female in her 40’s (confirmed 7.1.20);

Case No. 30 – Female in her teens (confirmed 7.1.20);

Case No. 31 – Male in his 30’s (confirmed 7.1.20);

Case No. 32 – Male in his 20’s (confirmed 7.1.20); and

Case No. 33 – Male in his 60’s (confirmed 7.1.20).

The Texas Department of State Health Services (“DSHS”) Dashboard¹ has not yet been updated to reflect these new cases. We anticipate that the DSHS Dashboard will be updated by tomorrow, and will provide an update tomorrow to share that information.

Region 11 of DSHS is reporting that Bee County has a combined total (both inmates and non-inmates) of 51 confirmed cases from inception of tracking through noon today.

Bee County is situated in DSHS Region 11. Region 11 tracks non-inmate COVID-19 cases in Bee County, including contact tracing and quarantine management. The DSHS Dashboard, on the other hand, is maintained by DSHS in Austin, and in Austin, DSHS counts both non-inmate and inmate cases together.²
